

Sterile Development and Fill & Finish of Applications

Siegfried provides contract development and manufacturing services for injectables, ophthalmics and otic / nasale forms from clinical through commercial phase. For injectables Siegfried supports sterile manufacturing of small and large molecules in vials, ampoules, pre-filled syringes and cartridges. Vials and ampoules are filled under aseptic conditions and terminally sterilized if needed. Ophthalmic forms as liquids are filled in plastic dropper bottles, ointments in squeeze tubes and nasale / otic forms are provided as plastic spray bottles or glass bottles. Our formulation expertise ranges from solutions, suspensions, emulsions, ointments and gels to sterile drug delivery devices. Our in-house, state-of-the-art development, microbiology and analytical laboratories ensure quality of product and process from incoming materials to finished products. Depending on the portfolio of the facilities, they have been inspected and approved by a wide range of international authorities, including the European and US authorities.
